



SIA Engineering Company Extends Maintenance Agreement with Hawaiian Airlines

SINGAPORE, 11 October 2022 – Mainboard-listed **SIA Engineering Company Limited** (“**SIAEC**”) is pleased to announce that it has signed an agreement with Hawaiian Airlines Inc. (“**Hawaiian Airlines**”) to perform airframe maintenance services for its A330-200 fleet. The agreement covers maintenance checks for 11 aircraft into Year 2027.

SIAEC, which recently won the 2022 “Asia MRO of the Year – Airframe” award by Aviation Week Network, will undertake the maintenance services for Hawaiian Airlines at its facility in Singapore.

Hawaiian Airlines, based in Honolulu, Hawaii, currently operates a fleet of 24 A330-200 aircraft, serving 13 gateway cities in the U.S.A and 9 destinations throughout Asia and South Pacific.

Mr Jeremy Yew, Senior Vice President Base Maintenance Services of SIAEC, said: “We are delighted to extend our partnership with Hawaiian Airlines with additional A330 C2 maintenance checks. This signing signifies the confidence that Hawaiian Airlines has in SIAEC's technical strengths and capabilities. We will continue to deliver best-in-class on-time performance through the implementation of LEAN methodology, and to provide quality services and strong engineering support to our customers.”

Mr Jim Landers, Senior Vice President, Technical Operations, said: “SIAEC has proven to be a trustworthy partner who expertly cares for our A330-200 aircraft during heavy maintenance visits. Our decision to extend our scope with SIAEC indicates our confidence that they share our commitment to deliver safe and reliable aircraft to the Hawaiian Airlines network.”

The transaction is not expected to have a material impact on the earnings per share or the net tangible assets per share of the SIAEC Group for the financial year ending 31 March 2023. None of the Directors and controlling shareholders of SIAEC has any interest, direct or indirect, in the transaction, other than through their shareholdings (if any) in SIAEC.
