

MR WILLIAM TAN RETIRES AS CEO OF SIA ENGINEERING COMPANY

Mr Png Kim Chiang will succeed Mr William Tan as CEO

Mainboard listed SIA Engineering Company Limited (SIAEC) today announced the retirement of Mr William Tan Seng Koon, age 62, as Chief Executive Officer of the Company with effect from 1 April 2015.

The Board of Directors is pleased to announce that Mr Png Kim Chiang, who is the Executive Vice President (Operations), will succeed Mr Tan as CEO.

The Board recorded its appreciation of Mr William Tan's contributions to the Company since his appointment as CEO in April 2001. Under Mr Tan's leadership, SIAEC has emerged as a leading player in the Asia-Pacific for aircraft maintenance, repair and overhaul services. He had served in various senior management positions in SIA and was appointed Senior Vice President (Services) of SIAEC in 2001. In 2005 and 2009, Mr Png was appointed Senior Vice President (Commercial) and Senior Vice President (Aircraft and Component Services) respectively. Since 2010, following his appointment as Executive Vice President (Operations), Mr Png has been overseeing the operations of Aircraft and Component Services, Line Maintenance and Fleet Management, as well as the support services of Marketing, Information Technology, Engineering, Quality, Safety and Facilities Development.

Mr Png is also the Chairman of Aviation Partnership (Philippines) Corporation, NexGen Network (1) Holding Pte Ltd and NexGen Network (2) Holding Pte Ltd, and a director of SIA Engineering (Philippines) Corporation, Singapore Aero Engine Services Pte Ltd and Hong Kong Aero Engine Services Ltd.
