



## **SIA Engineering Company signs MOU for Joint Venture with Moog Inc.**

**SINGAPORE, 17 February 2016** - Mainboard-listed **SIA Engineering Company Limited** (SIAEC) has signed a Memorandum of Understanding (MOU) with Moog Incorporated (Moog) to establish a joint venture to provide maintenance, repair and overhaul (MRO) services for Moog's products on Boeing 787, Airbus A350 and other new generation aircraft.

Under the MOU signed today, Moog will have a 51% stake in the joint venture, with SIAEC holding 49%. The Singapore-based joint venture will be the Centre of Excellence in Asia Pacific for Moog's products on both the 787 and A350 aircraft.

Mr. Png Kim Chiang, Chief Executive Officer of SIAEC, said: "We are delighted to work with Moog to provide comprehensive maintenance support for Moog products on the Boeing 787 and Airbus A350. This joint venture will enhance SIAEC's position as a leading MRO service provider for new-generation aircraft."

"Moog is excited to be working with SIAEC to establish an MRO facility in Singapore," said Mr. Mark Trabert, President of Moog Aircraft Group. "This venture will further enhance Moog's position as a world-class service provider to our airline customers and is a key part of our support strategy for this important region."

Mr. Lim Kok Kiang, Assistant Managing Director of Singapore Economic Development Board, said: "We are pleased to welcome this joint venture between Moog and SIAEC. The establishment of this joint venture attests to Singapore's status as an attractive business location for leading aerospace companies. This partnership will enhance Singapore's comprehensive MRO ecosystem by introducing flight controls component capabilities for new-generation aircraft."

The transaction is not expected to have a material impact on SIAEC's financial performance in FY2015/16. None of the Directors of SIAEC has any interest, direct or indirect, in the transaction.
